

Article Submission Agreement

This agreement governs the submission of articles to **AK Publishing LLC**, the parent company and publisher of **Empowering Humanity Magazine™**, including use on **EmpoweringHumanityMagazine.com**, affiliated websites, and promotional platforms. By submitting your article (“the Submission”), you agree to the following terms:

1. Publication Discretion

Submission does not guarantee publication. Articles are selected at the discretion of the editorial team and may be considered for future editions, blogs, or promotional features. If your article is not chosen for the current issue due to space limitations or editorial focus, it may be included in a subsequent issue or other publication platform. You will be notified if and when your article is published. Rejected submissions will not incur liability for missed opportunities, potential income loss, or other perceived damages.

2. Original Content and Rights

You confirm the Submission is your original work and does not infringe on third-party rights. If photos or other materials are included:

- You guarantee that you hold the rights to the photos or have obtained proper permissions from the copyright holder.
- You must credit the photographer or rights holder when applicable.
- **AK Publishing LLC** will not be held responsible for claims related to uncredited or unauthorized use of photos.

You agree to indemnify **AK Publishing LLC** and its affiliates against any claims, damages, or expenses related to content or photo disputes, including copyright claims.

3. License to Use

You grant **AK Publishing LLC** a non-exclusive, royalty-free, perpetual, worldwide license to distribute and promote your Submission. This includes, but is not limited to:

- Social media, partner platforms, and promotional materials
- Digital magazine platforms such as Zinio.com
- Print publications and sales

Once published, **AK Publishing LLC** is not responsible for the actions of third-party platforms that may share, distribute, or reuse your Submission.

4. Exclusivity Clause

By submitting your article to **AK Publishing LLC**, you agree not to publish the same article, or a substantially similar version, on any other platform, website, or publication for a period of forty-five (45) days following its publication by **AK Publishing LLC**. After this period, you may republish your article elsewhere, provided it includes a credit line stating: “Originally published by Empowering Humanity Magazine™.”

5. Editorial Process

You acknowledge that the editorial team reserves the right to edit your submission for clarity, grammar, and style. At the time of submission, you may choose to review and approve edits via email prior to publication. If you do not select this option, edits will be considered approved and your submission will proceed to publication accordingly.

You understand that post-publication changes to digital versions may incur an additional fee, and that changes to printed editions are not possible once finalized.

6. Compensation and Promotion

You acknowledge that your Submission is voluntary and unpaid. Contributors will not receive compensation or revenue share from any income generated by **AK Publishing LLC**, including but not limited to ad revenue, platform income (e.g., Zinio.com), or other promotional opportunities associated with the magazine or Submission.

If fees are required for your article’s inclusion in the magazine or other platforms, these fees will be communicated prior to publication and must be paid in advance.

13. No Refund Policy

All payments made to **AK Publishing LLC**, including but not limited to tier enrollment fees, publication fees, promotional services, and production charges, are non-refundable. This includes situations involving scheduling delays, editorial decisions, missed deadlines by the contributor, or changes in personal circumstances. By submitting payment, the contributor acknowledges and agrees that all fees are final.

14. Submission Deadlines, Materials & Missed Issue Responsibility

Contributors are solely responsible for submitting all required article content, photos, bios, links, and supporting materials on or before the communicated editorial deadline for their assigned issue.
